### First North American Serial Rights

1. The Contributor grants *The Garden Statuary* the right to be the first publication in North America to publish the Work.
2. The Contributor permits *The Garden Statuary* to publish the Work in both online and in print.
3. The Contributor permits *The Garden Statuary* to archive the Work on *The Garden Statuary* website. The Contributor reserves the right to request that their Work be removed from public access on the website for any reason at a later date, just as *The Garden Statuary* also reserves the right to remove the Work from the website for any reason at a later date.
4. The Contributor agrees to attempt to credit *The Garden Statuary* as First Publisher if and when the Work is republished in digital or printed form, with the understanding that there may be constraints outside their control that could prevent them from being able to properly credit *The Garden Statuary*.

### Warranty and Indemnities

5. The Contributor confirms that the Work is original to them. If any form of generative AI was used in their creative process, the Contributor agrees to provide a statement of explanation disclosing how and why it was used. *The Garden Statuary* reserves the right to revoke publishing based on nondisclosure.
6. The Contributor confirms that the Work contains no matter which is libelous or otherwise unlawful to their knowledge. The Contributor further agrees not to pursue legal action against *The Garden Statuary*, or its sponsors and associates, should there be any future claims to the contrary.
7. The Contributor confirms that they have the right to assign FNASR to *The Garden Statuary* and that no other individual or organization has already reserved the rights granted in this agreement.

### Non-Compete Clause

8. The Contributor agrees not to publish or permit others to publish the Work prior to its appearance in *The Garden Statuary*. The Contributor is welcome to submit or publish their Work elsewhere after its first appearance with *The Garden Statuary* either online or in print. The Contributor retains the right to

freely submit their Work to symposiums, workshops and conferences at any point before or after publication with *The Garden Statuary*.

**Manuscript Revisions and Suggested Edits**

9. *The Garden Statuary* agrees to provide the Contributor with suggested edits and revisions of the Work. If the Contributor does not respond to their suggested revisions in a reasonable and mutually agreed upon time, and if the revisions are necessary for grammar, spelling or coherency, the Contributor authorizes *The Garden Statuary* to make necessary changes to their manuscript without express permission.

**Payment and Compensation**

10. The Contributor acknowledges that *The Garden Statuary* is unable to provide them with any monetary compensation for their Work.

**Copyright Protection**

11. The Contributor understands the possible risks of publication and will not hold *The Garden Statuary* legally or financially responsible in the case that Work is used in unauthorized circumstances outside of the immediate control of *The Garden Statuary*. *The Garden Statuary* also agrees to attempt to protect the Contributor’s copyright as outlined in this agreement, with the understanding that their may be constraints outside their control.
